ACHF-03	Care Transition Record Transmitted	 A care transition record is transmitted to a next level of care provider within 7 days of discharge containing ALL of the following: Reason for hospitalization Procedures performed during this hospitalization Treatment(s)/Service(s) provided during this hospitalization Discharge medications, including dosage and indication for use Follow-up treatment and services needed (e.g., post-discharge therapy, oxygen therapy, durable medical equipment)
ACHF-04	Discussion of Advance Directives/Advance Care Planning	Patients who have documentation in the medical record of a one-time discussion of advance directives/advance care planning with a healthcare provider.
ACHF-05	Advance Directive Executed	Patients who have documentation in the medical record that an advance directive was executed.
ACHF-06	Post-Discharge Evaluation for Heart Failure Patients	Patients who receive a re-evaluation for symptoms worsening and treatment compliance by a program team member within 72 hours after inpatient discharge.
